We hereby inform you that as scheduled, the 41st Annual General Meeting (AGM) of the members of Vardhman Polytex Limited was held on Wednesday, 29th September, 2021 at 11:00 AM at Vardhman Park, Chandigarh Road, Ludhiana-141123, Punjab.

The company secretary commenced the meeting by welcoming the shareholders at $41^{\rm st}$ Annual General Meeting and introduced the directors sitting on the dais. As per Article 99 of Articles of Association of the company, Mr.Adish Oswal, Chairman & Managing Director occupied the Chair.

The requisite quorum was present, Mr.Adish Oswal, Chairman of the meeting, declared the meeting open. The Secretary informed that the notice dated 13th August, 2021 convening the AGM alongwith Annual Report for the FY ended 31st March 2021 has already been circulated by email and hosted on the website of the company and it may be taken as read.

The Secretary informed that the Auditors Report on the Standalone and Consolidated Financial Statements for Financial year ended March 31, 2021 contained a qualified opinion of Auditors. Ordinary Business:

- 1. Special Business:

- 3. Ratification of the remuneration payable to Cost Auditors for the financial year ending 31st March, 2022.
- 4. Appointment of Mr. Hardeep Singh as Independent Director of the Company.

The Secretary announced that voting by physical ballots will be done after the close of meeting for the members who had not exercised their votes through remote evoting. It was also informed that the results of the remote e-voting and physical voting by poll at AGM would be announced to Stock Exchanges and on the website of the company within two working days.
